



BOARD OF DIRECTORS NOMINATION APPLICATION - 2026

Thank you for your interest in possibly becoming a member of the board of directors here at Deuel County Farmers Union Oil Company (DCFU). To become a board member of DCFU, you must fulfill all the requirements below.

DIRECTOR QUALIFICATIONS

To qualify for and serve as a director, an individual must:

- Be a voting member of the cooperative (*actively engaged in farming and/or ranching and purchase \$5000 or more from the cooperative each year*) and not be in competition with the cooperative.
- Demonstrate leadership characteristics.
- Demonstrate understanding of cooperatives and their purpose.
- Have sufficient time to attend and participate in board meetings and be willing to attend director training sessions.
- Have the ability to read and understand fundamental financial statements.
- Have the ability to work well with others as a team and to support majority decisions.
- Be willing to place the interest of the cooperative above the interests of any other organization.
- Have not been employed by the cooperative during the three years preceding nomination.
- Be aware that favors will not be granted to any director, his/her family or relatives.
- Be willing to keep matters discussed at the board meetings confidential.
- Have the ability to recognize the continuing need for improvement and change in business practices.
- Have the ability to recognize the overall objectives of the cooperative and be able to see things in perspective.
- Have a strong interest in and current knowledge of economics and business conditions affecting agriculture and farmer cooperatives.
- Be unquestionably loyal to the cooperative, demonstrate faith in its aims and purposes, and be an active participant in its programs and services.

Applications must be delivered to the Administrative Office by 5pm February 23rd, 2026. Any applications received after this deadline will not be considered for election for the board of directors.
